	1. Integrated Regional Business Services Team – Presentation

Chairwoman Stoneman welcomed Jeff Hubert, Lake County Workforce Development Employment

Specialist and member of the Regional Business Services Team to the meeting. Jeff presented on the focus and goals of the integrated business service team. Jeff introduced the Business Services Team staff from

each local workforce area. He shared how the team addresses the needs of regional businesses, how they have integrated core partner agencies, along with the team discussing challenges and identifying solutions. Staff from every local area in the region are meeting regularly at different locations throughout the region to collaborate on these endeavors.

2. Lake County Workforce Development Board's Local Plan

Member Serino reviewed Governor Pritzker's Executive Order 2019-03 with the committee in relation to the local and regional planning efforts. Much discussion was around the board's response and the direction the board will take going forward to better align workforce resources to serve disenfranchised populations in communities throughout Lake County. Member Serino reviewed the Lake County Service Integration Action Plan and the committee discussed promising practices in relation to program access, technology, social media and website functionality, adult & dislocated worker Strategies, and priority of service. Some responses from the committee focused on the following:

- The board need to narrow the focus and concentrate on two specific sectors.
- Create a career pathway strategy.
- Educate the employers on how to utilize career pathways as a retention tool.
- Marketing and communication increased.
- Improve and increase engagement with post-secondary and secondary education.

Member Harris shared to the new manufacturing program with North Chicago Community High School targeting high school seniors. The objective is to create career pathways for high school students, while addressing the local need of manufacturing talent, and providing internships to young adults to skill them up.

Member Kurtz announced they just hired 2 New Talent Development Consultants.

Member Kurtz also shared a new grant the college received, Transform Lake County. This is a program that provides full-tuition grants in short-term programs. Additional scholarships are available to cover costs such as transportation, textbooks childcare and more. The goal is to create more equity in the Lake County workforce by offering an education with no cost to the student. 
Workforce Development: 4th Quarter Business Services Outcomes July 1st, 2019 – June 30th, 2020

Key Terms

- Job Center Customers: The Job Center of Lake County provides employment services (e.g. job fairs, workshops, sourcing resumes) to the public; individuals do not have to meet eligibility requirements to receive these basic services.
- WIOA Participants: Individuals enrolled in employment service programs which are funded by WIOA Title I funds; individuals must meet eligibility requirements to receive these services. Programs include Training and Work-Based Learning.
- Training: Participants purchase training services from eligible providers they select in consultation with the career planner. Training programs must be occupational in nature in high demand industries and must lead to the attainment of an occupational skill certificate, industry recognized certification, and/or licensure.
- Work-Based Learning (WBL): These programs allow participants to earn an income while gaining critical job skills on-site with an employer. WBL programs include: On-the-Job Training (OJT), Incumbent Worker Training (IWT), and youth/adult Internships.

Business Services Offered at the Job Center

Business Services by Industry (below): Survey of business services provided by the Workforce Development Department to employers within Lake County. Employers are grouped by industry. Industries that received the most business services include: Professional/Technology (over 100 services), and Transportation and Warehousing (over 90 services).


Employers Receiving Incumbent Worker Training (IWT) & On-The-Job Training (OJT) Services (below): Nine (9) individuals have been trained through the On-The-Job Training grant to date (\$77,595) and Two-Hundred and Sixty-Five (265) individuals have been trained by their employer through the Incumbent Worker Grant (\$218,546), and Thirty-Four (34) individuals have been placed in work base learning/internship opportunities (\$429,100).





Hires Per Industry (below): Two Hundred Ninety-Four (294) individuals received employment services through the Job Center and were hired in 7 industries.



Illinois Unemployment Rate Rises to 16.4% Amid COVID-19 Pandemic

SPRINGFIELD – The Illinois Department of Employment Security (IDES) announced today that the unemployment rate jumped +12.2 percentage points to 16.4 percent, while nonfarm payrolls shed -762,200 jobs in April, as the COVID-19 pandemic continued to impact Illinois businesses and households, based on preliminary data provided by the U.S. Bureau of Labor Statistics (BLS) and released by IDES. The monthly unemployment rate rose to a new record high since current methodologies were enacted in 1976 and the monthly decline in nonfarm payroll jobs also set a record. The March monthly change in payrolls was revised from the preliminary report from -34,100 to -60,900 jobs. The March unemployment rate was also revised from the preliminary report, from 4.6 percent to 4.2 percent, as a result of a downward revision to the number of people in the labor force in March.

The April payroll jobs estimate and unemployment rate reflects activity for the week including the 12th. The BLS has published <u>FAQs</u> for the April payroll jobs and the unemployment rate.

The state's unemployment rate was +1.7 percentage point higher than the record high national unemployment rate reported for April, which was 14.7 percent, up +10.3 percentage points from the previous month. The Illinois unemployment rate was up +12.2 percentage points from a year ago when it was 4.2 percent.

The three-month average Illinois payroll employment estimate was down -278,200 jobs during the February to April three-month period, compared to the January to March three-month period. The largest average declines were found in Leisure and Hospitality (-107,800), Trade, Transportation and Utilities (-37,700) and Professional and Business Services (-36,800).

"The COVID-19 pandemic has had an unprecedented impact on our economy, as has been the case in states across the nation," said Deputy Governor Dan Hynes. "As we move to safely reopen much of our economy, we are focused on ensuring working families and small business have the resources they need to recover, and we urge the federal government to step up and provide additional relief."

"As Illinois tackles this unprecedented crisis, Governor Pritzker has taken action to support a swift public health recovery that will in turn enable residents and businesses to make an economic recovery," said Erin Guthrie, Director of the Department of Commerce and Economic Opportunity. "This administration's focus on workforce development, rebuilding our crumbling infrastructure, and creating new industries will help us start to bring Illinoisans back to work and rebuild our economy."

Compared to a year ago, nonfarm payroll employment decreased by -822,800 jobs, with losses across all major industries. The industry groups with the biggest jobs decreases were: Leisure and Hospitality (-320,500), Professional and Business Services (-119,800) and Trade, Transportation and Utilities (-110,000). Illinois nonfarm payrolls were down -13.4 percent over-the-year as compared to the nation's -12.9 percent over-the-year decline in April.

The number of unemployed workers increased dramatically from the prior month, a +280.3 percent increase to 1,004,400, a new record high, and was up +270.6 percent over the same month for the prior year. The labor force was down -2.9 percent over-the-month and -5.2 percent over-the-year. The unemployment rate identifies those individuals who are out of work and seeking employment.

An individual who exhausts or is ineligible for benefits is still reflected in the unemployment rate if they actively seek work. IDES maintains the state's largest job search engine, <u>Illinois Job Link</u> (IJL), to help connect jobseekers to employers who are hiring, which recently showed 186,374 posted resumes with 62,412 jobs available.

- 2015-2019 seasonally adjusted labor force data for Illinois, and all other states, have been revised as required by the U.S. Bureau of Labor Statistics (BLS). The monthly historical revisions to state labor force estimates reflect new national benchmark controls, state working-age population controls, seasonal factors, as well as updated total nonfarm jobs and unemployment benefits claims inputs. Illinois labor force data were also smoothed to eliminate large monthly changes as a result of volatility in the monthly Census Population Survey (CPS) and national benchmarking. For these reasons, the comments and tables citing unemployment rates in previous news releases/materials may no longer be valid.
- Monthly seasonally adjusted unemployment rates for Illinois and the Chicago-Naperville-Arlington Heights Metropolitan Division are available here.
- Monthly 2011-2019 seasonally adjusted nonfarm payroll employment data for Illinois have been revised. To control for potential survey error, the estimates are benchmarked annually to universal counts derived primarily from unemployment insurance tax reports.
- Not seasonally adjusted jobs data with industry detail are available here. "Other Services" include activities in three broad categories: personal and laundry; repair and maintenance; and religious, grant making, civic and professional organizations. Seasonally adjusted data for subsectors within industries are not available.

Rapid Response/Layoff Assistance Activity during COVID-19 and prior to COVID-19

Background:

Lake County Workforce Development Department (LCWD) and Workforce Development Board have an established Rapid Reponse team that assist Lake County employers with consolidation, restructuring, layoffs, and downsizing assistance. The Rapid Response team consist of Department of Commerce and Economic Opportunity (DCEO), Illinois Department of Employment Security (IDES), Lake County Workforce Development (LCWD), and Employee Benefits Security Administration (EBSA).

Lake County has experienced increased temporary and permanent layoffs within the Retail, Hospitality, Food Service, Entertainment, Manufacturing, and Consumer Goods Industries. The local rapid response team is conducting virtual and physical layoff assistance and guidance for events affecting over 2000 workers within a variety of industries. LCWD has been engaged with each of these employers and has delivered Zoom Meetings, Employment and Training resources, Direct Hire opportunities, Source resumes of those affected by current layoffs, and provided Unemployment Insurance resources to the impacted workers and employers, along with giving each employer legislative updates that could positively affect their operations. The virtual layoff events provide stability, comfort, and increased opportunities for the impacted workers and the businesses itself.
