V. Presentation – Prosperity Agenda’s Family Centered Coaching Adoption

Presenter: Franceria Moore, [The Prosperity Agenda](#)

*The Family-Centered Coaching (FCC) framework was designed for the participant and their family support system. Individuals must set and achieve their goals based on their responsibilities of family. Coaching expertise for both the coach and the participant. The participant may have some barriers i.e. childcare, transportation and shelter for supporting the family network. Move away for transition; not passive but very active. Participants know themselves, and what is needed to take care of their personal needs. Put a plan in place not based on a timeline, but if the individual is ready for coaching. No judgement. Participant can think about and prepare for change. Start wide and narrow in on “what are your hopes and dreams?” Ask open-end questions. Family-centered coaching should be a pathway consisting of 3 levels: Adoption, Integration, and continuous improvement. We are treated like partners with individuals.*
