 AMS Elite Solutions, Inc Julie Savitt, President The goal of Apprenticeship is a career pathway so employers can develop and prepare to fill job openings in their future workforce. Apprentices receive financial assistance and employers pay wages, benefits, and apprenticeship costs. A Registered Apprenticeship Program (RAP) will provide mentors and training. Currently, there is a need for more employers to participation in apprenticeships for age 18+ years old who are interested in starting a career or changing careers.

College of Lake County (CLC) apprenticeship program provides support for Lake County's workforce needs and to create equitable opportunities for Lake County residents to secure employment and training. This will lead to jobs with family sustainable wages. CLC has three convenient campuses located in Waukegan, Grayslake, and Vernon Hills. CLC program are 4 semesters or an average of 2 years to complete. Participants must maintain good academic standing and good attendance at the worksite and classes to stay in an apprenticeship. Classes and work are limited to 40 hours per week. CLC regularly contacts all participating companies. Qualifications for apprenticeship requires an overall high school GPA of 2.5 or a 70% or higher score on the college placement test in math and reading. There needs to be a plan to address these barriers to qualify for an apprenticeship.

The Department of Labor industry sectors have added new Fall 2022 apprenticeships in Manufacturing, Education and Social Science. The average retention for apprenticeship completion is 91%. After the individual completes the apprenticeship 94% of employers retain the apprentice.

Youth Build Lake County (YBLC) is designed for youth enrolled in school, students who drop-out, currently earning a G.E.D or not quite ready for college. The participants are paid for on the job learning as well as classroom learning. The program is a type of Earn and Learn with flexible training schedules. The program creates home-grown talent and increases loyalty to the communities they have grown-up.

The Youth Conservation Corps (YCC) mentors and empowers young adults to succeed through education and training in life skills, career pathways and environmental stewardship. The Youth Summer Employment Program (YSEP) is 8-weeks of employment program for students 14 -24 years old who have not completed high school. There is success in bringing back companies for a work experience. The YSEP registration information is on the Job Center of Lake County website, their high school and word-of-mouth.

AMS has served the Northern IL, SE WI, NW IN area for over 15 years. As a WBE/DBE leader in the construction materials and logistics industry, AMS has built a strong reputation with its customers and vendors as a company you can trust. They provide comprehensive and creative solutions to daily projects while nurturing an environment that will empower people to learn, grow, give back and provide exceptional communication and service. They are actively seeking talent and the hourly wage has increase by \$2.00 over the past 2-years. Applicants must have a CDL and complete a specific number of hours. Currently, there is currently no apprenticeship program. They intend to create an apprenticeship program, and have it approved by their Union.
