1. City of Waukegan

Chief of Staff, George Bridges, City of Waukegan Human Resources Director, Tameika Jones, City of Waukegan

Tameika Jones introduced herself as the current Director of Human Resources for the City of Waukegan and welcomed the committee to City Hall.

VI. Updates and Information

1. Rapid Response Services at-a-Glance – Laid-Off Worker and Employers Antonio Garcia, Business Services Manager, Lake County Workforce Development

Member Garcia provided an overview of the Rapid Response program delivered by Workforce Development in partnership with state and local agencies. Member Garcia shared information on the Illinois' Work Adjustment and Retraining Notification Act (WARN). The WARN notice is required when there is a 33% mass layoff. In 2022 Lake County Workforce Development responded to six WARN notices and provided Rapid Response activities.

• 665 affected employees all in the manufacturing industry and companies located in Waukegan, Libertyville, Lake Bluff

The KPI results for Rapid Response for six companies:

- Filed WARN Notice 100%
- Received a layoff presentation 100%
- Allowed for employer engagement 100%
- Attained worker contact information 75% of 50% benchmark
- Received UI info "how to apply" 100%
- Applied through the Lake County Job Center VIS 10% of 10% benchmark
- 2. IWIB Business Engagement Committee Data

Member Serino shared that the IWIB Business Engagement Committee is charged with formulating data points to report business engagement across the state. Members contributed ideas on what meaningful data points could be reported.

3. Workforce Development's Strategic Communication Plan

Member Serino shared that Workforce Development has selected the communication firm to develop and execute Workforce Development's Strategic Communication Plan including strategies for the use of social media, update to the websites, communication materials and message for the individual and business customers and overall alignment across all medias and printed materials. This is a 12 month agreement funded through ARPA.


