1. Consumers Credit Union

Carla Schroeder, Talent Acquisition Director

Carla presented an overview of Consumers Credit Union. Consumers is a not-for-profit financial institution and one of the largest credit unions in Illinois. It was established in 1930. There are over 500 employees in 15 branch locations. Consumer Credit Union will be moving to Lake Forest in 2024. Currently, there are 17 interns/apprenticeships, both full-time and part-time, entry level to senior level.

1. Agnes Masnik, Northeast Regional Manager, Office of Regional Economic Development Illinois Department of Commerce & Economic Opportunity

Agnes Masnik is with DCEO Regional Economic Development team and works closely with workforce and economic development. Agnes provided an overview of the work and programs DCEO has available to businesses. DCEO is the state's economic development dedicated to creating economic opportunity for all Illinoisans by attracting job creators and bolstering small businesses. Top priorities are attracting and

retaining businesses, supporting small businesses and entrepreneurs, and building clean energy.

1. PY'23 WIOA Grant Allocations

The PY'23 WIOA Formula Grant has a 7% budget increase over last program year's grant.

- Workforce Development will be working with partners, College of Lake County and the City of Waukegan once the Illinois Climate and Equitable Jobs Act (CEJA) Notices of Funding is released.
- DCEO released a Notice of Funding to local workforce boards in response to a DOL Apprenticeship Expansion Grant.
