Unemployment Trends

2023 ⇒ 2024

The unemployment rate in Lake County, IL, fluctuated throughout 2023.

- 5.7% in August
- 5.2% in July
- 4.8% in June
- November 4.1%.

The 2024 workforce outlook emphasizes growth.

- Lower interest rates can stimulate economic activity by making borrowing cheaper.
- Inflation: The Federal Reserve expects inflation – to slip from 2.8% in 2023 to 2.4% in 2024.

Unemployment Trends

Summary:

- 216K new jobs added, bringing the total to 2.7M jobs
- Unemployment in the US (November) fell below historic lows of 3.7%
- 4.1% annual wage growth





Workforce Training Grants

- Workforce Development funds qualified individuals for short-term occupational training. The goal is for individuals to become more competitive for highdemand and high-wage jobs.
- Eligible individuals can receive up to \$10,000 in tuition assistance
- Individuals will receive career guidance
- Job search assistance is provided to aid in securing employment

Your Career Solution

The Lake County Workforce Development Department partners with local employers, colleges, universities, and private institutions to connect individuals to sustainable employment and wages.

Workforce Development funds qualified individuals for a paid work experience or short-term occupational training. The goal is for individuals to become more competitive for high-demand and high-wage jobs.

Paid work experience

- Qualified individuals are matched with an internship, allowing them to gain new skills to add to their resume or to establish contacts in a new career field.
- Locations and type of work experiences vary; some recent work experiences have been in fields such as IT, healthcare, and business.
- Upload your resume when you apply to the Virtual Information Session for consideration.

Training services

- Eligible individuals can receive up to \$10,000 in tuition assistance
- Individuals will receive career guidance and planning
 Support services are provided to assist individuals in completing their training
- employment

- Manufacturing Careers can include welders, machine operators, and engineers.
- Transportation / Logistics Careers can include heavy and tractor-trailer drivers, logisticians, and supply chain specialists.



PY21-22 Training Analysis: Major Industries









Unemployment Rate Math




November 2023 Employed352,205November 2023 Labor Force367,314November 2023 Unemployment Rate4.1%

But if we instead divided the Nov. 23 Employed number by the Nov. 2019 (pre-pandemic) Labor Force number of 377,502, that would yield an unemployment rate of **6.7%**.

Average of 1,244 units per year countywide.


Lake County communities permitted more units in 2017 than in subsequent years or the prior two.

Single-family levels have remained typical, while fewer multi-family units have been permitted per year.

Greatest construction in South Central with significant number of multi-family units.

Compared to neighboring counties, spike in McHenry County in 2021, primarily single-family.







CHILD CARE

Licensed Care is Unavailable for Most

The current licensed child care capacity in Lake County could only serve:

- Approximately a quarter of children age 5 and under, and
- About 37% of those children in working families (i.e. children age 5 and under with one working parent ir a one parent household, or two working parents in two person households).




Lake County Families are Cost Burdened by Child Care


The U.S. Dept. of Health and Human Services advises that child care costs should not exceed 7% of a household's budget, but many Lake County families are spending more.

Other Key Findings Re: Child Care

- Only 5 of the 36 elementary school districts in Lake County have confirmed full-day preschool programs. Many parents reported that they cannot utilize the preschool program at their school district because it is only half day and does not fit their work schedule.
- None of the reporting school districts in Lake County offer before- and after-school care to preschool children as they often do for elementary school students. Therefore, even programs that do extend for a full school day, such as Preschool For All-Expansion programs, do not work for many families.
- Survey data indicated that 30% of families reported that child care for early morning, late evening, and weekend hours were among the hardest to find.

KEY TAKEAWAYS

Ensure Lake County is an attractive place for workers to live and WORK


Add housing, including a variety of price points and types


