#### 1. JTED Grant Application Overview and Discussion

Lake County Workforce Development (LCWD) shared that they are working on a grant that would expand services similar to the Revive lake County program to provide training to justice impacted individuals. One of the focuses on this grant will be to involve more community organizations to help remove the silos of providers supporting justice impacted individuals.

#### 2. Update on Youth Task Force

LCWD updated the committee on youth task force activities including recent funding secured to support the Youth Action Plan through data analysis, asset mapping, and stakeholder engagement. Two national consulting firms were selected to assist with these efforts.

Dr. Karner shared that many high schools in the county use School Links as a way to manage college and career readiness information. The grant applied for includes funding for all schools to utilize the same system so employers only have to enter their information into a single platform.

#### 3. Apprenticeship Update

LCWD is launching a new youth apprenticeship program in partnership with FHI 360. This program will help strengthen the youth servicing system by creating a community of practice among participating youth serving organizations. The goal is to increase these organizations' capacity to serve marginalized youth through apprenticeships and other career pathways.
