V. Regular Agenda:

- Maximizing Workforce Potential Through CEJA: Expanding Talent Pipelines Beyond Green Jobs
- Inside the Climate Equitable Jobs Act: Workforce Hub, Training Pathways and Employer Engagement
 - Sara Espeland and Antonio Garcia provided an update on the Climate Equitable Jobs Act (CEJA) workforce network grant.
 - The grant provides \$3.5 million to College of Lake County and Lake County Workforce Development to support clean energy workforce training programs.
 - Target populations include justice-impacted individuals, foster care graduates, displaced energy workers, and individuals from Equity Investment Eligible Communities.
 - Key Discussion Points:
 - o Training and Apprenticeship Opportunities:
 - The program will offer Clean Energy Bridge Classes to introduce participants to solar energy, wind energy, electric vehicle (EV) maintenance, and HVAC.
 - A structured Apprenticeship Pathway is in place, allowing participants to progress into paid apprenticeships with clean energy employers.
 - The goal is to place 50 individuals in clean energy jobs by the end of the first grant year.
 - o Employer Engagement:

- Employers in Lake County's clean energy sector are being invited to participate in hiring program graduates.
- A follow-up meeting will be scheduled with the Chamber of Commerce and local utility providers to increase engagement.
- o Program Impact Measurement:
 - Quarterly employer engagement metrics will be tracked, including recruitment numbers, job placements, and retention rates.

VI. Updates

• NAWB Community of Practice for Skills First Hiring and LER (Learning and Employment Records)

Jennifer Serino shared that Lake County Workforce Development has been selected as one of seven workforce areas to participate in a community of practice focused on skills-first hiring and learning and employment records. This initiative is designed to help workforce organizations collaborate nationally while developing best practices and governance strategies around AI utilization in hiring, credentialing, and workforce development.

She emphasized that this selection is an exciting opportunity for Lake County to influence how AI is integrated into workforce systems and employer hiring processes. The team will engage in monthly cohort meetings and a visit to Washington, D.C., where they will collaborate with other selected workforce areas to shape future workforce governance strategies.

• Chamber of Commerce RFP

Goals of the RFP:

- Enhance business outreach efforts to better connect local employers with workforce training programs.
- Increase public-private partnerships to improve job placement services and hiring incentives.

- The LCWDB Business Services Team will review the RFP and determine potential areas for collaboration.
- Employer Engagement Workshops will be planned to discuss hiring challenges and solutions.
